CHILD TAX CREDIT- UPDATE

• 2020-2021 the Child Tax Credit was increased from \$2,000 to \$3,000 for qualifying child dependents 6-17 years old and \$3,600 for children 5 and younger. In addition, the rules allowed for Taxpayers to receive Advance Child Tax Credit payments in the last 6 months of the year in 2020 and the balance of the credit on when they filed in 2021.

2022 TAX YEAR CHANGES

- There were no advance child tax credit payments in 2022
- The amount of the credit is again \$2000 for qualifying dependents 16 and younger
- The credit will be refundable up to \$1,500 (up from the 2020 when it was \$1,400)

Unless Congress changes the rules this will apply in 2023



EARNED INCOME CREDIT- UPDATE

- Tax Year 2022, EITC (Earned Income Tax Credit) ranges from \$560 to \$6,935, depending on your income, filing status and the number of qualifying children you claim. (in 2023 the EITC range is \$600 - \$7,430)
- People without children may also qualify for this credit.
- The EITC is a refundable credit that will reduce a
 Taxpayer's liability and can also turn into a refund. In
 some cases, the refund may be more than the Taxpayer
 paid in taxes.
- If you claim EITC, the IRS, by law, cannot issue the refund until mid-February.



If you buy a new plug-in electric vehicle (EV) or fuel cell vehicle (FCV) in 2023 or after, you may qualify for a clean vehicle tax credit.

Who Qualifies

- You may qualify for a credit up to \$7,500 (TY 2023) under Internal Revenue Code Section 30D if you buy a new, qualified plug-in EV or fuel cell electric vehicle (FCV).
- The credit is available to individuals and their businesses.
- To qualify, you must:
- Buy it for your own use, not for resale
- Use it primarily in the U.S.

The credit is nonrefundable, so you can't get back more on the credit than you owe in taxes. You can't apply any excess credit to future tax years.
